Minutes of the Annual Stockholder's Meeting of the Soaring Society of Dayton

Date: Tuesday April 8, 2003, 7:15 pm.

Location: Clubhouse, 5385 Elbon Road, Waynesville.

The meeting was called to order by the vice president of SSD, Robert Root, as the president was out of town. In attendance were 18 stockholders. The minutes for the annual stockholder's meeting in 2002 were distributed and approved.

The treasurer gave an overview of income and expenditures in 2002. The largest expenditure in 2002 was for the purchase of a tractor and the down payment for the runway drainage. On the income side were the payments by members for bays in the third hangar. The hangar has been constructed in the first months of 2003 and thus it will show up as expenditure in the current year. In the past year 210 shares were sold and 127 were redeemed so that 3077 shares were outstanding on December 31, 2002. The treasurer also stated that in 1976 seven members owned 50% of the stock in SSD, whereas today it takes at least 110 members to account for 50% of the stock.

The vice president stated that for 2003 no major purchases are anticipated. The usage of the two place gliders will be monitored in order to determine if the Blanik should be kept or replaced. It was mentioned that two club members made a request to take the Blanik to Florida in the coming winter for a commercial operation there. The benefits and drawbacks as far as the club is concerned were discussed briefly. Any decision was deferred to the CCSC board and SSD board and it was recommended that the request should be resubmitted with more details. The Schweizer 1-26B has a relatively low weight limitation and it will replaced by a D or E model if an opportunity should arise.

From comments of members it appears that the conversion to a public use airport is a decisive issue. The SSD board was criticized for tabling this issue for one year at its board meeting in March. It was recommended that CCSC should revisit the issue, if necessary appoint a committee for further studies, and then report to the SSD board.

The secretary reported that votes for 40 shares were still needed in order to reach the 50% quorum. The motion was made to continue the Annual Stockholder's Meeting at the next SSD board meeting

on Saturday, April 19^{th} , 2003. The motion was second and approved unanimously.

Saturday April 19, 2003: The secretary reported that votes for 1673 of the 3092 outstanding shares had been received, so that the required quorum has been achieved. The votes were 309 for Gabbard, 1141 for Hurst, 903 for Lohre, 1319 for Lubon, 1002 for Sorrell and 345 abstained. The motion was made to accept the election results. The motion passed and thus John Lubon, Jim Hurst and Aaron Sorrell are members of the SSD board for the next three years.

The Annual Stockholder's Meeting for 2003 was adjourned at 9:55 a.m.

Liaison with CCSC Board: Bob Root


The Minutes of the previous meeting were not available.

There were discussions regarding (a) the progress of the drainage project, (b) leasing of farm acreage and (c) improved utilization of aircraft. No action was taken on these matters.

A motion was passed to investigate the availability of a 1-26 D or E model, which would not have the weight limitations of our current N2429W. Bob Root and Joe Jackson were authorized to evaluate any candidates that might appear and negotiate the possible purchase for a price up to \$12000. The meeting was adjourned at 12:42 PM.
