Changes to CCSC Uniform Operating Procedures (UOP)

Following publication of the proposed changes made to the UOP's in the June, 2004 issue of the Frequent Flyer, Greg McDowell, one of CCSC's flight instructors, pointed out that the revised wording of Section 4.1 Eligibility, while meant to clarify solo eligibility requirements, inadvertently made it impossible for a transition power pilot to be able to solo the SGS 2-33, Blanik L-23, or SGS 1-26 without their already having a glider rating. Since this was obviously not the intent of the changes, the CCSC Board has proposed new wording that corrects the previous oversight. We would like to thank Greg McDowell for pointing out this error to the Board so that we could correct it.

Also, after lengthy discussion at the July 3, 2004 CCSC Board meeting, the Board voted to retract the new Section 5.7, Responsibilities of Flight Instructors previously proposed as published in the June, 2004 CCSC newsletter.

The following details the UOP changes approved at the July 3, 2004 CCSC board meeting. In accordance with the CCSC Bylaws, the changes approved by the board will become effective 30 days after being published in the newsletter unless written objection is received from at least 20% of the membership.

Changes to UOP's:

Section 4.1, Eligibility (change paragraphs as follows):

SGS 2-33, Blanik L23

Initial solo flight requires compliance with applicable sections of 14 CFR Part 61 for solo eligibility, dual CFIG instruction flights, and CCSC CFIG logbook endorsements. For student pilots and licensed pilots without glider ratings, subsequent solo flights, second through ten, require a dual instruction flight and CFIG logbook endorsement for each day. After the tenth flight subsequent flights require logbook endorsement and check rides at the instructor's discretion. Rear seat operation requires a separate CFIG endorsement.

CCSC MEETING MINUTES June 5, 2004

In attendance were Jim Lowe, Joe Jackson, Dave Rawson, Dick Holzwarth, Brian Stoops, and Dave Menchen.

Meeting called to order at 9:45am

OLD BUSINESS

The charge for aero retrieves was discussed with the focus on assuring that we are charging enough to cover all of our costs. We still have very low rates compared to other operations and want to keep it that way if at all possible. We will continue to monitor the cost of operation for the Pawnees to be sure our price is in line. Rolf was doing some research and may pass that on to Dave.

The first aid kits in the trailer have been replenished with the missing supplies. Everyone should be made aware of the kits including the one in the clubhouse.

The subject of CCSC becoming a public use airport was discussed briefly but tabled until Mike Karraker can make his report.

The qualifications for flying the "new" 1-34 were discussed with the decision to keep the current requirement of Private Pilot Glider (or better) and a front seat sign off in the L-23 and a ground sign off by an approved instructor. We will review these requirements in the fall after reviewing the results of the summer flying season.

NEW BUSINESS

The process for collection of dues and fees was discussed with the decision to add some verbiage to the 60day late notice.

Dick discussed the Wright Memorial and the Region 6 meet. The sign up rate has been lower than he would have hoped for and he expressed concern with going forward with the Region 6 contest. The board expressed our support for whatever decision he comes to.

Joe has spent some time looking into communications options to aid in contests and daily operations. He has investigated the use of various long-range wireless phones for use on the flight line, and various Internet options that would provide access to weather and other information. A brief discussion of the possibility of running communication wiring to the flight lines ensued. Further investigation of our options by Joe was recommended.

The various members presented their reports and the meeting was closed at 11:50am

CCSC MEETING MINUTES July 3, 2004

In attendance were Joe Jackson, President; Dave Menchen, Maintenance; Mike Karraker, VP; Dick Holzwarth, Social; Dave Rawson, Publicity; Rolf Hegele, Secretary, and Jim Lowe, Treasurer. The previous minutes were reviewed and approved. The Region 6 south Contest was officially cancelled due to lack of committed contestants. The two UOP changes published in the previous Newsletter were discussed. The changes to Section 4.1 were approved and will go into effect by July 10, 2004. Based on some concerns as discussed in the meeting, the addition of Section 5.7 was dropped. Joe will survey the flight instructors and Jim Hurst and Mel Williams will recommend appropriate wording.

The SSA issued an e-mail with ideas on how to increase membership. One of their recommendations was to establish a national Introductory Instruction Package (IIP). After discussion on the idea's merits, our feedback will indicate interest in the concept. Also in attendance was Buck Arnold from the SSA. He was gathering information on how the SSA could help Clubs prosper. It was suggested that the IIP include 3 flights rather than just one; insurance deductibles for club ships need to be increased; Clubs could use access to some aviation legal counsel. He encouraged other ideas and offered his e-mail for other suggestions. (buckarnold@aol.com). He asked about our participation in the Young Eagles. These are EAA flights that the SSA has insurance for. He also asked about our interest in a student program to which we responded positively. Another subject was sister clubs and there was mixed reaction from the board and members.

Mke Karraker offered to take on the purchasing of shirts and will coordinate his activities with Linda. Bill Maxwell indicated that he would not maintain the Tri-Cubs and no one else volunteered. A problem was identified with the green golf cart, but it was related to the meter on the charger. The financials were reviewed and approved with the caveat that the weather was not kind to us this spring. The youth camp was a significant success; the CCSC Board congratulates and thanks all who made it possible. The Board was asked to consider establishing an "adult soaring camp". While the board decided to take no action to create such a camp, interested members are welcome to organize one. Please note that CCSC members can operate from CCSC any time they can arrange for ground crew and a tow pilot. Joe indicated that there was an incident in which the horizontal stabilizer of a Pawnee was damaged. A formal safety investigation will be conducted. The meeting was adjourned at Noon.

MINUTES OF SSD BOARD MEETING July 17, 2004

The meeting was called to order by President Lubon at 9:58 AM.

Minutes of the previous meeting were reviewed and approved. A Treasurer's report was not available. It was reported that all the golf carts were in working order. Bill Maxwell has received no complaints this month.

The next meeting is scheduled for 9:30 AM on August 21, 2004. The meeting was adjourned at 10:45 AM.
