Ready... Set... Go...

I have tried to get around and observe every crew. I want to commend you ALL on your efforts and hard work. However, there is still a blaringly obvious problem, I would like to take a few minutes to address.

This problem was addressed in the Crew Chief's meeting and left up to the Crew Chiefs to address. Since I have seen a wide spread epidemic I thought I would address the problem my self.

The problem is that people are taking too long to get ready, thus causing the towplane to sit idling and burning gas. Who is paying for that gas? You are... with higher prices because we are using and paying for extra fuel. Let's look at this scenario...

Let's say the average crew does 40 flights a day, and each of flights the pilot takes an extra 3 minutes to get ready. Yes, a simple 3 minutes. That is 120 minutes or 2 hours that the towplane is sitting idling, or about 8 flights a day that are missed. So we are throwing away \$\$\$ and also missing opportunities to get more revenue for your club. So we can continue to upgrade our fleet.

Have you ever noticed that the private (sailplane) pilots are usually in the cockpit before the towplane is on the ground? Well they are. They have done all of their checks and getting settled into the cockpit and are ready to fly. I would like to see more of that from the training membership. Put a little extra urgency in your preparation. Here are a few things you can do to help with that urgency.

- 1. Be Prepared. Have all your stuff and know what you are going to do.
- 2. Find your instructor and talk to them before you get in the plane.
- 3. Know what plane you are going to fly and check it out before you are 2nd in line.
- 4. Be in the cockpit of your plane while the plane ahead of you is launching.
 - Students this may require you to be in the plane before your instructor gets there, but have your logbook and tow card ready.
 - If you are not ready, do not get in the plane until you are. This may require waving off a tow, and taking the next one. I would rather see you do that, then have the towplane sit idling.

I understand that there are going to be different circumstances that may require you to break these suggestions. That is fine... but DON'T do it on every flight.

This will also require the crews to be prepared and have planes staged in proper order and be prepared to move a plane that is not ready.

I am not trying to be a hard @\$\$ about this, I just wanted to let you know about an observation I made on most crews and ask that you try and do your part and help out where you can, to minimize the delayed take-offs. Thanks for your attention to this matter and KEEP UP THE GOOD WORK!

New Ground Traffic Pattern at West End of Field

The CCSC Board is establishing a new traffic pattern for vehicles and pedestrians at the west end of the field. From now on, the CCSC Board requires that all traffic reaching the end of the gravel path past the clubhouse and campground area stay to the left and proceed alongside the campground and the woods. Traffic going back towards the clubhouse should also stay to the left alongside the woods. The idea is to always pass behind the towplanes and whatever gliders or other activity is going on in the cleared area alongside the runway. (At the campground end, the new traffic lane is marked with a rope.)

This new pattern applies to ALL traffic, members on foot, golf carts, personal cars. Golf carts or members actually engaged in moving sailplanes on or off the runway may transit across the area alongside the runway. Other than this, we want you, yes, YOU to go around the back. We ask your cooperation in complying with this new procedure, and we ask crew chiefs to begin enforcing it.

The idea here is to keep people and vehicles away from towplanes as much as possible, and to keep the area clear for towplanes to enter and exit. This new procedure really allows us to operate on the west end in the same manner as on the east end, where we ask traffic to follow the path through the woods, and stay clear of the operating area.

CCSC Board Minutes

September 4, 2004

In attendance were Joe Jackson, President; Brian Stoops, Operations; Dave Menchen, Maintenance; Bill Paar, Grounds; Dick Holzwarth, Social; Dave Rawson, Publicity; Jim Lowe, Treasurer; and Rolf Hegele, Secretary. The previous minutes were reviewed and approved with one modification: we will use our normal gift certificates for charitable purposes, which will be charged at normal member rates. The Treasurer's report was accepted as is. The results of the financial review were presented. Revenues are down due to lower membership and the loss of income from no Regional Contest and no air show participation. Expenses appear to be in line with projections. It was agreed that the trends will continue to be watched for any anomaly. Bill Gabbard indicated that his account was charged for a guest ride that he piloted and his account was now being shown in arrears. It was pointed out that all guest flights are charged to the crew chief's account and it is his responsibility to collect the money. Jim Lowe will talk to Sara to correct Bill's account.

Dave Menchen offered to buy a camera and printer for about \$100 to put in the trailer. Its use would be to document significant activities as well as guest rides. The board took no action on this item. It was pointed out that the Grob needed some maintenance: the wing root tape needs to be replaced and the front vent window needs to be replaced. It was pointed out that the Plane Crews, in conjunction with the maintenance director, have responsibility for these kinds of repairs. It is however every member's responsibility to bring items to the attention of the maintenance director or the Crew Chief.

Dick Holzwarth requested clarification on the new traffic pattern at the west end of the field. He will prepare a Newsletter article indicating that all traffic: pedestrians, cars and golf carts, are all to go behind the leach field. Linda Murray presented the new clothing lines. She recommended that we obtain a new display case and a process by which the items would be available for purchase by quests. The club will look for a new, larger display case.

A question was raised as to whether a Board Member must be a member of the club. A review of the current By-Laws indicated that there is no limitation or restriction on who can be on the board. We received a letter from the Waynesville Police Department reminding us not to fly low over the Sauerkraut festival. Dave Rawson will prepare a Where-to-Fly update for the SSA website. The Ohio Department of Taxation notified us of a new tax structure and the information was forwarded to Jim Lowe. Chris Welsh and Paul Fisher are new tow pilots for the club. Because of family health situation, a recent new member requested he be terminated. The board agreed to reimburse him his initiation fee less flying expenses. The UOPs have been updated and are available on our website. With no further business, the meeting was adjourned at 12:10.

SSD Board Meeting

September 18, 2004

Those present: Root, Towne, Maxwell, Schmidt, Hurst, Detert, Lubon and Norb Maurer. Absent: Sorrell. Visiting: Chris Palmer, Pat DeNaples

The meeting was called to order by President Lubon at 9:40 AM. The minutes of the previous meeting and the financial report were reviewed and approved.

At the previous meeting, Chris Palmer had alerted the Board that the gang mower was requiring excessive maintenance and that spare parts were not available. He was instructed to investigate the cost and availability of a new (or used) mower. Chris reported on several mowers which are available at a cost of \$10,000 to \$11,000, one being a 17 foot wide mower which had advantages of cost, performance and interchangeability of parts. The board authorized Chris to proceed to buy a replacement mower for up to \$11,000, using his judgment to choose from those available.

Concern was expressed at the previous meeting about the deterioration of the picnic shelter and Norb Maurer was to investigate the cost of replacing the roof. This structure is now used as a storage facility for the small tractor and several club trailers. Norb reported at this meeting that he had a bid of \$3200 for replacement of the roof including new plywood. There is some possibility of an increase in plywood cost due to the recent hurricanes, so the Board authorized \$3500 for this project and asked Norb to proceed.

It was reported that Paul Schweizer had died recently and a memorial service is scheduled in Elmira. Pat DeNaples and Wally Detert planned to attend the service and Wally suggested that the club make a donation to the Soaring Museum in Paul Schweizer's name. The Board approved a donation of \$500.

The next meeting will be had at 9:30 AM at the gliderport on Saturday October 16, 2004

The meeting was adjourned at 11:00 AM.
