The minutes were reviewed and accepted. The treasurer's report was also reviewed and accepted. The tractor is being evaluated for repair. The four bladed prop suffered tip damage while being put into the hanger. It will be sent out for evaluation.

The OX Roast is the only social function being planned for Memorial weekend. There will be a Cross Country Clinic on Saturday and Sunday. Bob Root expressed thanks to the Board for allowing the K-21 to go to the ridge. It was a successful outing for a good week of flying.

The new K-21 incurred a major problem. The main wheel bearings failed because of excessive buildup of mud and grass. Crews have not been cleaning the aircraft at the end of the day and allowing the mud to cake and dry. IT IS IMPERATIVE THAT CREWS TAKE CARE OF THE AIRCRAFT, especially when there is soft field. A high pressure wand has been purchased to help in cleaning out the wheel wells.

An update on the youth camp noted that they will have a FAA speaker to discuss landouts and survivor skills. This discussion will be open to all club members. There were no delinquencies of note and four new members were approved. Welcome to Bruce Dybvad, Chris Dybvad, Joey Coomes, and Carlo Montemagno.

There being no further business, the meeting was adjourned.

Two requests for stock redemption were approved.

The floor for the new towplane hangar was discussed. The cost estimate of \$5000 did not include the apron, which will require grading. A fire extinguisher for the new hangar was discussed, and Dave Edwards was authorized to obtain a suitable one.

I also thank all the instructors and fellow CCSC glider pilots who gave me invaluable training on the ground by sharing with me valuable knowledge and the occasional horror story, appropriately told, of course, not to mention the occasional tall story as well, which I much appreciated and enjoyed.

CCSC is about flying. During this year I made 29 flights, 20 of which were in September and October alone. CCSC Meeting Minutes 1 April, 2006

In attendance were Dick Holzwarth, President, Andrew Dignan, Vice President, Dave Rawson, Facilities, Dave Menchen, Operations, Steve McManus, and Jim Lowe, Treasurer.

The minutes from the prior meeting were approved – moved by Dick Holzwarth, seconded by Linda Murray- all in favor. The Treasurers report was also accepted. We are slightly ahead of budget.

Lease issues were discussed. The new lease is being reviewed by John Lubon. Some members want it reviewed by an independent attorney with no immediate resolution on that issue. The grounded and past due list was reviewed. Pat is handling as usual and no unusual circumstances require board attention at present.

We have 12 people signed up for the wireless internet in the clubhouse at a rate of \$5 per person. This cost is totally born by the users, no club monies are involved. Chuck Lohre requested some free guest rides for the media prior to and during the Regional contest. This will be discussed at greater length with Chuck since some feel the way these experiences are represented in the media is not always positive, and may not be a desirable thing.

Dave Menchen will provide a list of crews requiring ground crew in order of priority to the training crew (first Sunday). First Sunday will then notify newly trained crew members of their crew assignment based on the list. If there are issues or conflicts they can resolve them with Dave Menchen. Also discussed a cross country clinic in place of the Wright Memorial Glider meet, which was cancelled this year for lack of an interested party to take charge and do the work involved. John Lubon will be in charge of implementing the cross country clinic if it happens. Some discussion was had on the issue of instructor/mentor requirements for cross country training. The consensus was that the current requirement that said instructors have at least gold distance should be retained.

Dick Holzwarth moved to adjourn, seconded by Dave Menchen, all in favor.
