NEW BILLING SYSTEM DEBUT

For many years, CCSC has been using a FoxPro program to manage the Club's finances. However, as hardware and systems evolved, FoxPro was delegated to a back shelf without support or upgrades. Therefore, last year we started to review alternatives and talked with a number of other Clubs and organizations to gather their inputs. After reviewing the alternatives, the general consensus was that QuickBooks provided a flexible alternative and that it will integrate the entire Club's banking and P&L into a single system, thus minimizing any potential for mistakes in data entry. We developed a Microsoft Access front end to capture the flight data and Garry Print organized and structured Quickbooks for the Club. As of December, we have been running both systems so we can validate the accounts and ensure that the aging is running properly.

We are now ready to 'roll out' the new system and this month you are seeing the results of a lot of hard work and effort by many people. The new look is based on CCSC Statements. There are two major changes other than the look: Every flight will be presented in three rows: the Tow Fee; the Aircraft Flight Charge; and the altitude charge, shown as "Tow Fee per 100ft". The other big change will be that all Statements will be printed on the 3rd of every month and the payments will be due by the end of the month in order to avoid a late charge. Initially we will continue to mail the Statements along with the Newsletter, but QuickBooks has the capability to e-mail invoices which will be implemented once we've had several months' experience. Should any problems be identified, please forward them to Sara Palmer at businessmanager<at>soarccsc.com or you can contact Jim Lowe or myself at any time.

Several other changes that should be noted: Previously family and youth memberships were incorporated into a single invoice; Under Quickbooks, these accounts have been separated and will be sent to the addresses on record (they are not all the same). Please coordinate any updates with us. We are also still working on how to allocate a single check into various accounts, so bear with us, but let us know how you want the payments applied.

CCSC BOARD MINUTES - APR 2ND

CCSC Board of Trustees Meeting Minutes for April 2, 2011

The CCSC Board of Trustees conducted a regular meeting in the clubhouse on April 2, 2011. The meeting was called to order at 9:40 a.m. by Paul McClaskey, President.

Board members present at Call to Order: Paul McClaskey, Tom McDonald, Rolf Hegele, Jim Lowe, Michael Hayden, John Murray, Dave Coucke. Seven members present; Steve Statkus and Andrew Dignan absent.

Secretary's Report – Michael Hayden reported that Norm Leet has applied for membership. Norm introduced himself to those present and the Board welcomed him aboard. Michael reported that he mailed the March invoices and newsletters from Mason, again, and requested that anyone failing to receive same notify him. The Board considered a motion to approve the corrected Minutes for the March 5, 2011 meeting as presented by Michael on March 30, 2011 for approval.

Vote: All present in favor. Result: Approved.

Treasurer's Report – Jim Lowe presented an Account Balances Report as of March 31, 2011 showing a balance on hand of \$25,645 with both cash inflow and expenses tracking near budget. Several accounts are in arrears and Pat De Naples has begun contacting these members. He and Rolf will review the notification and collections processes with the Board in the May 7 meeting. Due to the higher price of the most recent fuel delivery, the fuel charge for tows will increase to 30 cents per 100 feet effective on April 1. The Board considered a motion to approve the Treasurer's Report as presented.

Vote: All present in favor. Result: Approved.

Andrew Dignan joined the meeting following the above vote; eight members now present.

Operations Report - Tom McDonald reported that many pilots are not field-current. The Board considered a motion to apply the existing reimbursement policy to instructor refresher training obtained outside the biennial FIRC session, up to the amount approved for FIRC participation.

Vote: Paul McClaskey abstained; all others present in favor. Result: Approved.

Maintenance Report – Paul McClaskey reported in Steve Statkus's absence that annual inspection on 2-

33 15H has been completed and a wing repair on 2-33 16Q is underway.

Facilities Report – As communicated previously, the Board designated April and November as Club Clean-up Months in lieu of holding individual clean-up days. Dave Coucke presented a work list for April with tasks to be completed by the various crews during the month. This list will be published in the April Frequent Flyer.

Social Activities Report – Andrew Dignan reported that a potluck dinner will be held on April 16, the same date as the SSD Board meeting. Andrew has posted the events calendar for 2011 on the club website and will provide instructions in the April Frequent Flyer for accessing it.

Note of Appreciation – The Board expressed appreciation to Henry Meyerrose and helpers for the repair of the clubhouse fireplace and to Garry Print and helpers for the extensive work on the Grob 102 and its trailer.

Safety Review Report – In Steve Statkus's absence, Paul McClaskey presented bound copies of the special safety review committee's report to the Board members, who consented to study its content and discuss follow-up action at the May 7 Board meeting.

Board Appointment – As communicated previously, Tom McDonald tendered his resignation from the Board in order to assume new duties as Chief Flight Instructor. The Board considered a motion to accept Tom's resignation, thank him for his service, and to appoint John Atkins to serve out the remainder of the term expiring in 2012 to which Tom was elected, with both Tom's resignation and John's appointment to take effect on April 3, 2011.

Vote: All present in favor. Result: Approved. The Board then considered a motion to appoint John Atkins as Director of Operations.

Vote: All present in favor. Result: Approved.

The Board asks all who are interested in serving on the Board to inform the Board in order to facilitate the search for candidates for any future openings.

Accounting Software Transition Report - Rolf Hegele reported that the April invoices will be generated via QuickBooks, rather than via FoxPro, and the format will change somewhat. From April onward, all payments will be due by the end of the

month in which the invoices are mailed.

Business Manager Replacement – Sara Palmer has reassumed the duties of Business Manager.

Winch Storage Request - The Board considered a motion to allow the winch formerly located at Waynesville to be stored on the grounds and to charge a monthly storage fee corresponding to where it is stored, i.e., outside storage equates to a tiedown, etc.

Vote: Paul McClaskey opposed; all others present in favor. Result: Approved.

The meeting was adjourned at 12:03 p.m. by unanimous consent.

The meeting was called to order at 9:45 a.m. by John Lubon. The minutes of the February meeting were reviewed and approved. The treasurer's report was also reviewed and approved. Dieter reported that the books have been reviewed and the taxes prepared by a CPA.

Dieter reported on progress in closing out the stock escrow accounts. He has issued 69 shares of stock and made some refunds to individuals who have withdrawn from CCSC. He is preparing bills for 44 active members with escrow balances less than \$100, billing them for the balance needed to purchase one share of stock. Eight inactive members have escrow balances, and refunds

will be mailed to them.

There are currently 3338 shares of SSD stock outstanding. 171 are owned by former members for whom we do not have a valid address. 36 shares are owned by individuals who are listed as "Terminated," but who have current addresses on file. Ballots for the upcoming election will be mailed to them. DeNaples and John Lubon will work with the business manager to make corrections to the new database.

Old Business:

Election: Changes to ballot language were discussed. and language was agreed on. Ballots will be printed and mailed within the next week.

Code of Regulations: Garry Print has created an electronic file of the SSD Code of Regulations. incorporating recent amendments. For one amendment passed in 2005, which changed the day of the week of ...continued on page 4

POP QUIZ - L/D FUN

This month's pop guiz reviews a lift / drag chart. Both the chart and the questions are the ones used in FAA knowledge tests. Be careful of units. These questions use statute miles, not nautical. Also, be careful to read the units on the chart, and make sure you are looking at the part that corresponds to the question asked. Find answers and a discussion of common errors later in this newsletter.

How many feet will the glider sink in 1 statute mile at 53 MPH in still air?

a) 171 feet b) 144 feet c) 211 feet.

At what speed will the glider attain a sink rate of 5 feet per second in still air?

a) 79 MPH

b) 75 MPH

c) 84 MPH

How many feet will the glider descend at minimum sink speed for 1 statute mile in still air?

a) 132 feet b) 180 feet c) 170 feet

At what speed will the glider gain the most distance while descending 1,000 feet in still air?

a) 53 MPH

b) 44 MPH c) 83 MPH

What approximate lift/drag ratio will the glider attain at 68 MPH in still air?

a) 10.5:1 b) 28.5:1 c) 21.7:1




Figure 1 - L/D Chart Answers on page 5

the annual meeting, record of passage cannot be Ways of dealing with the discrepancy were discussed. Board members were uncertain whether the Code of Regulations is part of the Articles of Incorporation and whether amendments need to be filed with the Secretary of State. John Lubon proposed obtaining a copy of the current Articles of Incorporation on file with the state, reviewing and updating them as needed. Lucy Anne McKosky will pursue this.

SSD-CCSC Lease: John Lubon reported that renewal has been delayed. He will update the lease with the same terms as last year. The board discussed the proof

of insurance for private gliders operated on the field, which is required in the lease. Options for enforcement of this provision were discussed. The board consensus was that the SSD board reserves the right to audit the CCSC files of private glider insurance certificates.

Grob-102 Trailer: Garry Print reported that structural repairs have been completed. However, it is not feasible to remake the wing dollies, and he recommended purchasing Cobra wing dollies. It will also be necessary to replace the gas struts which support the hatch cover. He requested that an additional \$1000 be appropriated

Pop quiz answers and explanations. Correct 170 feet is about how far the glider descends in one answers are in boldface.

How many feet will the glider sink in 1 statute mile at 53 MPH in still air?

a) 171 feet. The 30.9:1 glide ratio is a given on the chart. 5280 feet divided by 30.9 = 171.

144 feet is how far the glider will sink in one minute at that speed.

At what speed will the glider attain a sink rate of 5 feet per second in still air?

a) 79 MPH. Enter the chart on the right at 5 fps and move left to intersect the "sinking speed" line. Read straight down to find the speed.

84 MPH is what you get if you move left to the wrong line, then read down.

How many feet will the glider descend at minimum sink speed for 1 statute mile in still air?

b) 180 feet. It takes 82 seconds to travel one mile at 44 mph. 82 seconds x 2.2 feet/sec = 180 feet. 132 feet is how far the glider descends in one minute at that speed.

mile at the best glide speed, not the min sink speed.

At what speed will the glider gain the most distance while descending 1,000 feet in still air?

a) 53 MPH. The 1000 feet given in the question is irrelevant. The glider will gain the most distance at this speed regardless of the altitude involved.

44 MPH is the min sink speed, not the best glide. This means the glider will lose the least altitude per unit of time, as opposed to unit of distance.

83 MPH just happens to be where the descent rate and L/D lines cross on this chart.

What approximate lift/drag ratio will the glider attain at 68 MPH in still air?

10.5:1. This is the number of feet lost per second at this speed, not the L/D ratio.

b) 28.5:1. Enter the chart from the bottom at 68 mph. Read up to the L/D glide angle line, then left to find the ratio.

21.7:1. Is the wrong answer you get if you read up to the "sinking speed" line, and then left to find the ratio.

for these repairs. A motion to authorize \$1000 in additional funds for this project was approved unanimously.

Fireplace Repairs: Materials have been purchased at an approximate cost of \$100. Henry Meyerrose will coordinate the repair. Dan Reagan has repaired the doors.

Glider Radios (2-33s): This year's budget priorities do not include purchasing radios for the 2-33s. John Lubon noted that the instructors are discussing this issue and one or more radios will probably have to be purchased eventually.

Water Well: No new information has been obtained. Dick Scheper suggested the possibility of drilling an exploratory well which would provide more definite information on water quality and flow rate. The pressure relief valve on the hot water heater in the clubhouse has been replaced, which has significantly reduced water consumption. The need for better reporting of leaks was noted.

New Business:

Farmhouse Lease:

The lease on the farmhouse will be due for renewal in June. Concerns were expressed about the adequacy of the performance of the business manager functions. Field maintenance has been adequate, but a CCSC board member is currently handling the business

manager responsibilities. Options were discussed, including modifying the lease to remove the business manager duties and requiring the lessee to be responsible for electricity and fuel oil, changing the term to six months, and not renewing the lease.

The meeting was adjourned at 11:50 a.m. The next meeting will be Saturday, April 16, 2011, at 9:30 a.m. at the CCSC clubhouse.
